For institutional shareholders, the Power of Attorney must be signed by the representative of the capital contribution at Vietjet or the legal representative of that organization. For authorization, the institutional shareholder sends the authorization dossier to Vietjet including the Power of Attorney and a copy of the authorized person's ID card/ID card/passport. For the Authorized Party being a foreign organization: authorize organizations/individuals to give opinions that need to send a scanned copy of the Power of Attorney to Vietjet to verify the validity of the power of attorney. Voting Form sent to the Company after the time limit specified in the content of the Voting Form are invalid. Voting Form votes that are not sent back shall be considered as votes that do not participate in voting.
