VIETJET, SSI HEATED UP THE STOCK MARKET DEVELOPMENT 2019 **CONFERENCE**



On February 22, the Stock Market Development 2019 Conference was hosted by the Ministry of Finance and the State Securities Commission in Hanoi, at the presence of Deputy Prime Minister Vuong Dinh Hue, Minister of Finance Dinh Tien Dung, Deputy Governor of the State Bank Nguyen Thi Hong and leaders from organizations and listed companies. As at January 31, 2019, Vietnam stock market had 755 shares and listed fund certificates on two stock ex-

changes and 804 shares registered on UPCom with the total value of more than VND 1,235 trillion, an increase of 26% compared to the end of 2017. Market capitalization in 2018 increased by 12.7% compared to 2017, equivalent to 71.6% of 2018 GDP, exceeding the target that the Government set out for 2020. Speaking at the conference, Vietjet Vice President Tran Hoai Nam assessed that Vietnam's stock market has become one of the effective capital mobilization channels, participating in the stock market has enabled businesses in building a corporate governance system, liquidity and transparent information for sharehold-

ers. According to VP. Nam, Vietjet's shares have attracted foreign capital inflows to be enlisted in VN30 Index

as the result of transparent information and compliance with regulations on information disclosure and

good business results, as well as a series of other strict criteria on capitalization, liquidity, freefloat rate ... "Vietjet has made great improvements along with the stock market: since Vietjet implemented IPO and traded shares on Ho Chi Minh City Stock Exchange in 2017, the current capitalization value of the company has exceeded VND66,000 billion (equivalent to nearly USD3 billion). Vietjet's market capitalization was achieved thanks to the public transparent information in the market, which was certified by international auditing, year-on year business growth, along with high dividends payout offering great profits to shareholders.

2018 is also the record breaking year for Vietjet with revenue from main business activities increasing by 49%, reaching 112% of the plan with very low debt to equity ratio at 0,04 times. Vietjet remained in the top 10 largest tax payers with the total tax collection and submission of more than VND6,192 billion, total revenue of VND52,400 billion, an increase of 24% compared to the previous year. Other key statistics include total profit before tax reached VND5,830 billion, Equity reached nearly VND14,000 billion, an increase of 31.4% compared to 2017, Return on Equity (ROE) reached 37.6%. Price to Earnings ratio (P/E) is at an attractive level of 11.5%.
