#### **Key Highlights**

- Carried 8.27 m passengers in H1 2017, an increase of 22.4% vs H1 2016.
- Capacity in H1 2017 is 9,43 m seat flow an increase of 22 % vs H12016
- Vietjet opened 1 new domestic route and 12 international routes in H1 2017
- Fuel price increased **22.2%** vs H1 2016 from 67.5USD/barrel to 82.5 USD/barrel in H1 2017
- The Revenue increased 45.9% vs H1 2016 to VND 10,802.5Bil(1) in H1 2017.
- Profit Before Tax increased 45.2% reached VND 1,907 bil(1) in H1 2017
- RASK up 3,3 % from strong growth of passenger transportation and ancillary revenue.

- In H1 2017, Vietjet paid 10% cash dividend (in a total of 119% dividend of 2016) and 20% cash dividend (FY2017)
- Vietjet will pay 40% stock dividend in 3Q of 2017 (FY 2017)
- Vietjet was granted <u>Full Membership by IATA</u> on 18 Feb 2017, following the award of <u>IOSA</u> <u>certificate</u> in 2015.
- On 28 February 2017, Vietjet listed its shares on Ho Chi Minh Stock Exchange. On 30 June 2017, VJC share price increased by 49% against the IPO.
- On July 19th, 2017, the Groundbreaking Ceremony for Vietjet Aviation Academy was held in Saigon High Tech Park (SHTP) located in District 9, Ho Chi Minh City. The Academy is expected to be in operation in 2018, with full flight simulator, supported by Airbus.






### **Operating Statistics**






> Vietjet SkyBoss waiting room at Tan Son Nhat Airport had been upgraded and opened on July 2017. The luxurious, convenient and modern ones.

## **Fleet Expansion**

- Vietjet's aircraft fleet by 30<sup>th</sup> June, 2017 stood at 45 aircraft including 30 Airbus A320s and 15 Airbus A321s with the average age of 3.12 years.
- The fleet of aircraft has seat configuration from 180 to 220-230 seats and the designs are in tune with the low cost airline business model.
- Vietjet made an order of 119 Airbus A320/321 aircraft and an order of another 100 737MAX 200 aircraft with Boeing.
- The orders with Airbus and Boeing will be completed at the end of 2023.




- Total Assets: increased 47.8% from 15,761 VND billion in 1H2016 to 23,300 VND billion in 1H2017.

- Cash and Cash equivalent grew up 35.5% to 2,637 VND billion in 1H2017 compared to same period in 2016.





TOTAL REVENUE (VND'bil)





OPERATING PROFIT (VND'bil)



PROFIT BEFORE TAX (VND' bil)









## **Solid Growth In Ancillary**


- Ancillary revenue per pax: increased 20% from 11.3 USD/pax in 1H2016 to 13.6 USD/pax in 1H2017.

#### **Excellent Financial Performance (Consolidated Fs)**

- Revenue up 30.8% from H1 2016 based on increase in passenger carried (+46%) and growth in ancillary revenue (+52%)
- Operating Profit increased
   45.2% compared to last year.
- Revenue per ASK increased 3.3% YoY due to strong growth from passenger carried (up 22.3%) and stable load factor at 88%.
- Cost per ASK impacted by higher fuel price (up 2.1%), however
   Cost (ex-fuel) per ASK decreased
   7.4% from 2.43 in H1 2016 to
   2.25 US cents in 1H2017.
- RASK CASK: up 12.5% YoY.




### **Excellent Financial Performance (Consolidated Fs)**

- Total assets: increased 49.6% from 16,541 VNDbil in 1H2016 to 24,747 VNDbil in 1H2017.
- Total Equity increased 111.9% to 7,321 VND bil in 1H2017 due to successful IPO in Feb 2017 and strong Retained Earnings from 2016.
- Net Debt/ Equity decrease from O.9x to O.5x in 1H2017 due to substantial growth in equity and strong cash balance showing the better financial position of the Company.
